If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. RVs and Travel Trailers will have to go to Isanti County Fairground, Cambridge MN website for camping. Only have 50 amp plug ins, if you have 30 amp will have to bring an adapter. There hook ups for water. Free use of dump site for campers. Camping will be close to the show site. 36 RV sites available. Reservations are not necessary when entering fairgrounds at gate. An office will be on the right. You can pay camping costs when you arrive. The gate is always open. If the office is closed, then pay the next day. The showers and bathrooms are about one block from the show site. Three satellite bathrooms will be near the show site.

### NON-REGULAR CLASSES, INVOLVING SINGLE DOG ENTRIES

#### VETERAN DOG & VETERAN BITCH CLASS

Classes are for dogs/bitches seven (6) years old and over. Winners may compete for Best of Breed competition if otherwise undefeated on the day of the show.

Note: "Neutered dogs and spayed bitches may compete in the Veterans Classes only at independent specialties and/or those all-breed shows which do not offer any competition beyond Best of Breed." AKC Rules Applying to DOG SHOWS, Chapter 11, Section 8.

#### BEST PUPPY COMPETITION

Offered for dogs & bitches entered and exhibited in the puppy classes to compete for Best Puppy In Specialty. Puppies winning Best of Breed or Best of Winners in regular conformation classes are automatically Best Puppy In Specialty.

#### BEST BRED-BY-EXHIBITOR COMPETITION

Offered for dogs & bitches entered and exhibited in the Bred-By-Exhibitor class to compete for Best Bred-By-Exhibitor in Specialty. Dog or Bitch winning Best of Breed or Best of Winners in regular conformation classes are automatically Best Puppy in Specialty.

#### BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of record and dogs according to their owner's records have completed the requirements for a Championship but whose Championships are unconfirmed. The showing of dogs whose Championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a Championship according to the owners' records.

#### SELECT DOG / SELECT BITCH

After Best of Breed, Best of Winners and Best of Opposite Sex are judged, the remaining Champions of Record will stay in the ring. The judge may award Select Dog and/or Select Bitch from among the Champions of Record. The award of Select Dog or Select Bitch is at the sole discretion of the Judge.

#### \*Bred by Exhibitor Class Eligibility

Due to a rule change, effective September 2002, the AKC has asked that the following items be included in all conformation Premium Lists.

- All dogs entered in the Bred-By Class must be **individually registered** with the AKC.
- The person handling the dog must be a breeder of record of the dog and an owner of record of the dog.
- To exhibit in this class, family members must be a breeder and owner of record.

## NON-REGULAR CLASSES, INVOLVING MULTIPLE DOG ENTRIES

### STUD DOG CLASS

For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately or in another class. Get MUST be entered in one of the Regular Classes. The Stud Dog and his Get shall be considered as one entry and requires only one entry fee, this being the additional class fee if the Stud Dog is entered in another class. If entered for Stud Dog Only, Regular Class fee will be charged for the Unit. The Stud Dog MUST be shown in the ring with his Get. Get only to be judged, based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard for its breed. As the judge's decision in this class will be based on the merits of more than one dog, no one of the dogs making up the entry judged first in the class will be eligible to compete for Best of Breed (Variety) by virtue of having won this class. Entry is \$30.00 as an additional entry.

### BROOD BITCH CLASS

Same as for Stud Dog Class except substitute Brood Bitch for Stud Dog and Produce for Get.

### BRACE CLASS

Two Dogs of the same breed and must have at least one common owner. Both dogs must be entered in another class. (regular or non-regular).

### TEAM CLASS

Four Dogs of the same breed and must have at least one common owner. All dogs must be entered in another class. (regular or non-regular).

### BEST TYPE

After best of breed dogs entered in type class will be judged by conformation judge for best Irish Wolfhound type as described in the Irish Wolfhound Standard of Excellence. Dogs must be entered in regular classes.

### BEST GAIT

Following best of breed dogs entered in gait class will be judged by conformation judge for best Irish Wolfhound gait as described in the Irish Wolfhound Standard of Excellence. Dogs must be entered in regular classes.

## Puppy Sweepstakes

Puppy Sweepstakes are open to all dogs and bitches, 6 months and under 18 months of age on the day of the show. All dogs and bitches entered in the Puppy Sweepstakes must be entered in a regular class at the show. Entries shall be made at the same time and on the same form as the Regular Classes. Entries shall be made in the space marked "Additional Classes" on the entry form by writing "Sweepstakes." The entry fee is \$25.00. Sweepstakes will be divided by sex and will be judged prior to the Regular Conformation Classes.

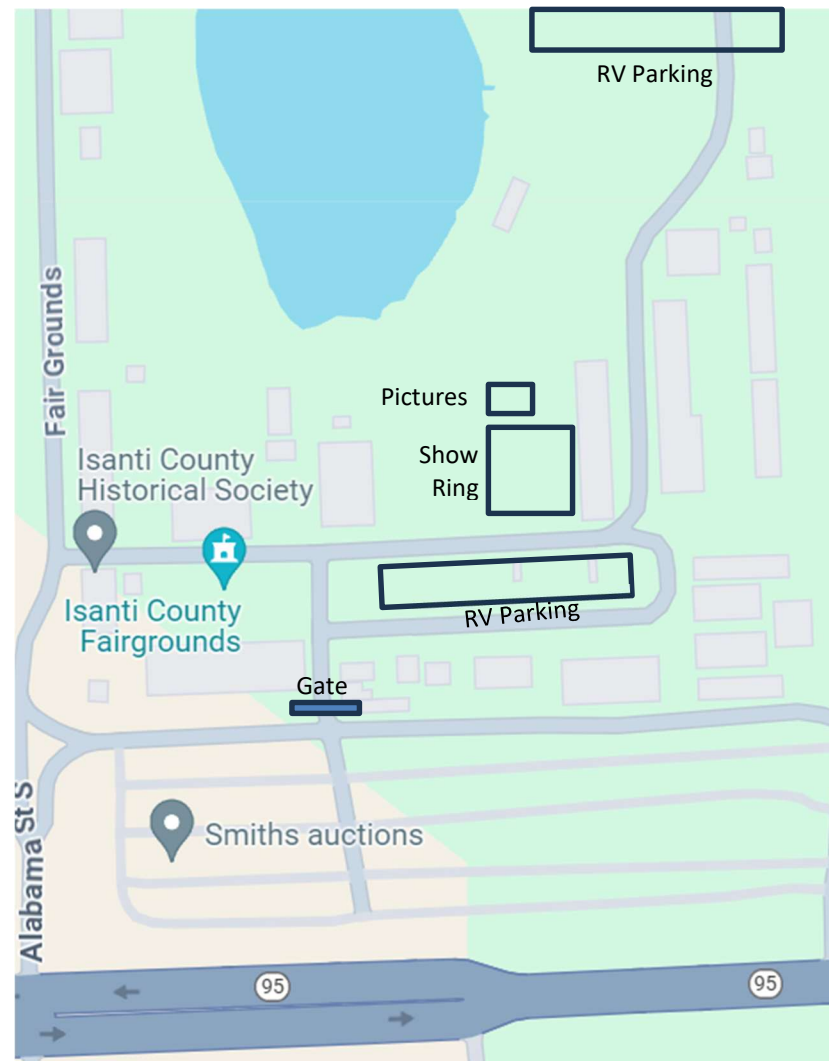
### ISANTI COUNTY FAIRGROUNDS, 3101 MN-95, CAMBRIDGE, MN 55008
